The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, subparagraph 1.7, Article 26 and Article 30 of Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Articles 4 and 6 of Rule on Licensing of Energy Activities in Kosovo;
- Provisions of Article 37 of Law no. 02/L-123 on Business Organizations, and
- Application, dated on 21.06.2016, on extension of the license for electricity import, export and transit (hereinafter "electricity wholesale supply (trade)"), submitted by "GEN-I Tirana" LLC., having its address at: St. Gustav Mayer, 16, 10000, Pristina, Republic of Kosovo,

in its session held on 14 December 2016, issued the following:

DECISION

I. The license for electricity wholesale supply (trade) of "GEN-I Tirana" LLC, with license number ZRRE/Li_34/12 is hereby **EXTENDED** for the period from **29 December 2016** to **28 December 2021**.

Reasoning

- o On 21.06.2016, Energy Regulatory Office (ERO) received electronically the Application for license extension from "GEN-I TIRANA" LLC. Branch in Kosovo.
- ERO evaluated that the company in question has acted in accordance with ERO's instructions and requests, stipulated in Application for license extension.
- Following the submission of all relevant documents and evidence from the company in question, required in accordance with the application, ERO evaluated it, and based on legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.
- **II.** The Electricity Wholesale Supply (Trade) License allows the licensee to carry out the abovementioned electricity activity in Kosovo, with an installed capacity of up to **400 MW**, in accordance with the License and other applicable legislation.





- III. The Decision shall be issued in Albanian language and will be translated in Serbian and English language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- **IV.** The Decision shall enter into force on the date of approval by ERO Board and shall be published on ERO's official website.

Legal Advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
