- Provisions of Article 15 and Article 26 of Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 8, paragraphs 4,8 and 11 of Law on Energy (Law no. 05/L-081);
- Request of Transmission System Operator and Market Operator (KOSTT JSC.) dated on 22.09.2016 on review and approval of the document: Electricity Annual Balance 2017;

**in its session held on 23 December 2016, issued the following:**

## **DECISION**

**I. Electricity Annual Balance 2017 is hereby APPROVED.**

### **Reasoning**

- 1) On 22 September 2016, Energy Regulatory Office (ERO) received from KOSTT JSC a request for approval of the document Electricity Annual Balance 2017. The document is compiled by KOSTT, based on Law on Energy (L05/081).
  - 2) ERO also received comments from MED and provided its written comments on the concerning issues. Following the inclusion of comments and suggestions from common meetings, on 22.12.2016, the document was submitted as a final version to ERO for approval.
  - 3) Based on Article 8 of Law on Energy, following the analysis of the final document, ERO considers that it fulfils the criteria for approval, therefore taking into account the legal provisions mentioned in the introductory section of this decision, decided as in the enacting clause of this Decision, hereby approving the document **Electricity Annual Balance 2017**.
- II. Taking into account the impact of different parameters of the Balance in determination of tariffs, ERO is entitled to make changes in the values presented in this document, depending on the circumstances.**



- III. With respect to execution of Article 42, paragraph 2.3 of Law on Energy Regulator, no. 05/L-084, Energy Regulatory Office shall monitor the implementation of Electricity Annual Balance in order to verify the realization of data and information presented in this Balance.
- IV. The Balance shall be published on ERO's official website as a unique document of ERO along with Thermal Energy Balance 2017.
- V. The Decision shall be issued in Albanian language and translated in Serbian language and English language. In the event of any discrepancy between the versions, the Albanian version shall prevail.
- VI. The Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website where the document shall be published as well.

**Legal Advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
