The Board of Energy Regulatory Office ,

Based on:

- Provisions of Article 8 paragraph 1 sub paragraph 1.6, Article 14 paragraph 2 sub paragraph 2.2, Article 25, Article 29 and Article 30 of the Law on Energy Regulator (Law No. 03/L-185);
- Provisions of Article 4, Article 6 and Article 18 of the Rule on Licensing of Energy Activities in Kosovo;
- The application on licensing the activities of electricity import, export and transit, submitted to ERO on 14.04.2016 by "PETROL TRADE SLOVENIJA" L.L.C Company, having its address at "Miradi e Epërme", F.Kosovë, Republic of Kosovo.

in its session held on 23 June 2016, issued the following:

DECISION

- I. "PETROL TRADE SOLVENIJA" L.L.C Company, with license number ZRRE/Li_53/16 is hereby **GRANTED** the License for Electricity Import, Export and Transmission, for the period from **23 June 2016** to **22 June 2021**.

Reasoning

- On 14.04.2016, Energy Regulatory Office (ERO) received from "PETROL TRADE SLOVENIJA" L.L.C Company the application with relevant evidence on licensing the activity of electricity import, export and transit .
- ERO evaluated that the company has proceeded in accordance with ERO instructions and requests/ evidences required in Licensing Application for Import/Export and Transit of Energy.
- Following the submission of all documents and evidence by the previously mentioned company, ERO, evaluated it and based on legal provisions mentioned in the introductory section of this decision, has decided as in the enacting clause of this decision.



- II. The license on electricity import, export and transit allows the licensee to carry out the aforementioned activity of electricity in Kosovo with a capacity up to **100 MW**, in accordance with the License and other applicable legislation.
- III. The Decision shall be issued in Albanian language and will be translated into Serbian and English language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- IV. The Decision shall enter into force on the date of approval by the Board and will be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
