The Board of Energy Regulatory Office,

Based on:

- Article 9 paragraph 1 subparagraph 1.7, Article 15 paragraph 1 subparagraph 1.15, Article 25, Article 26 paragraph 1 subparagraph 1.2 and Article 43 paragraph 1 of Law on Energy Regulator (No. 05/L-184);
- Article 4, Article 5, Article 13 par. 1 and Article 14 of Rule on Authorization Procedure for Construction of New Generation Capacities;
- Administrative Instruction No. 01/2013 on Renewable Energy Targets;
- Article 4, paragraphs 9,10 and 11 of Rule on Support Scheme;
- Decision no. V-810-2016, dated on 19 May 2016 on determination of Feed-in Tariff for electricity generation from Renewable Energy Sources;
- Application/Request for Authorization for construction of new generation capacities for electricity generation from water, in the location HPP Prizreni 4, CA Jabllanicë, with an installed capacity of 2.83 MW, in Municipality of Prizren, dated on 18.04.2016, of "gEnCi" LLC. Company, having its address at: St. "Mark Isaku", no. 46, 10000 Pristina, Republic of Kosovo, and
- Application for Admission to the Support Scheme;

in its session held on 11 November 2016, issued the following:

DECISION

On Notification for Preliminary Authorization

- I. **PRELIMINARY AUTHORIZATION** is issued to "gEnCi" LLC. company, for development of the project for construction of new generation capacities for electricity generation from water, in the location HPP Prizreni 4, CA Jabllanicë, with an **installed capacity of 2.83 MW**, in Municipality of Prizren, Republic of Kosovo.
- II. The applicant "gEnCi" LLC. Company shall be granted the FINAL AUTHORIZATION for construction of new generation capacities from water, following the fulfilment of requirements deriving from Articles 14 and 15 of Rule on Authorization Procedure and other requirements of other applicable legislation related to construction of new generating plants.



- III. Decision on Notification for Preliminary Authorization does not entitle the holder to start construction of new generating plant before it meets all conditions and requirements set forth in item II herein.
- IV. The Notification on Decision for Preliminary Authorization determines targets availability as well as admission of the applicant to the Support Scheme and automatic guarantee of feed-in tariff.
- V. The Notification on Decision for Preliminary Authorization stipulates that the applicant is guaranteed the bond of Power Purchase Agreement with the Public Supplier for a period of ten (10) years, which shall be concluded at least 30 (thirty) days before the date of commencement of generating operation.
- VI. The Decision on Notification for Preliminary Authorization is issued for one (1) year period, and within this period the applicant is obliged to meet the requirements under item II. of the enacting clause of this Decision, and shall request in writing the granting of Authorization for construction of new generation plants.

Reasoning

- On 18.04.2016, ERO received from “gEnCi” LLC. Company the application for obtaining the authorization for construction of new generation capacities for electricity generation from water, in the location HPP Prizreni 4, CA Jabllanicë, with an installed capacity of **2.83 MW**, in Municipality of Prizren, Republic of Kosovo.
 - On 18.04.2016, ERO received from “gEnCi” LLC. Company the application for admission to the Support Scheme.
 - Following the evaluation of requests and evidence attached to the application and receipt of other additional supplementary evidence, ERO concluded that “gEnCi” LLC. Company has proved its suitability for development of the project for construction of new generation capacities for electricity generation from water. It also evaluated the request for admission to the Support Scheme, and based on legal provisions mentioned in the introductory section of this decision decided as in the enacting clause of this decision.
- VII. The Decision shall be issued in Albanian language and translated in Serbian language. In case of any discrepancy between the versions, the Albanian version shall prevail.
 - VIII. The Decision shall enter into force on the date of approval by the Board and shall be published on ERO’s official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO’s website, whichever occurs last.
