- Article 4, Article 5, Article 13 paragraph 1 and Article 14 of Rule on Authorization Procedure for Construction of New Capacities;
- Administrative Instruction No. 01/2013 on Renewable Energy Sources Targets;
- Article 4 paragraphs 9, 10 and 11 of the Rule on Support Scheme;
- Decision no. V-810-2016 dated on 19 May 2016 on determination of Feed-in Tariff for electricity generation from Renewable Energy Sources;
- Application/Request for Authorization for construction of new generation capacities for electricity generation from the hydro power plant, HPP "Erenik", located in CA Jasiq, with an installed capacity of 1.86 MW, in Municipality of Junik, dated on 12.01.2017 of "Security Team Kabashi K" LLC, having its address at: St. "Rruga e Kocit" n.n, Istog, Republic of Kosovo, and
- Application for admission to the Support Scheme;

### In its session held on 16 March 2017 issued the following:

#### **DECISION**

### On Notification for Preliminary Authorization

- PRELIMINARY AUTHORIZATION is issued to "Security Team Kabashi K" LLC for construction of new generation capacities for electricity generation from the hydro power plant, HPP "Erenik", located in CA Jasiq, with an installed capacity of 1.86 MW, in Municipality of Junik, Republic of Kosovo.
- II. To the applicant "Security Team Kabashi K" LLC. shall be granted the FINAL AUTHORIZATION for construction of new generation capacities from the hydro power plant, after it meets all the requirements deriving from Articles 14 and 15 of the Rule on Authorization Procedure and other applicable legal requirements related to construction of new generation plants.





- **III.** Decision on Notification for Preliminary Authorization does not entitle the holder to start construction of new generation plants before it meets all the conditions and requirements set forth in item II. herein.
- IV. The Notification on Decision for Preliminary Authorization determines the targets availability and the applicant's Admission to the Support Scheme and automatic guarantee of the Feed in Tariff.
- V. The Notification on Decision for Preliminary Authorization determines that the applicant is guaranteed the bond of Power Purchase Agreement with Public Suppliers for a 10 (ten) years period, which will be concluded at least 30 (thirty) days before the date of commencement
  of generating operation.
- VI. This Decision on Notification for Preliminary Authorization is issued for one (1) year period, and within this period the applicant is obliged to meet the requirements under item II of the enacting clause of this Decision, and shall request in writing the granting of Authorization for construction of new generation capacities.

#### Reasoning

- On 12.01.2017, ERO received from "Security Team Kabashi K" LLC. the application for obtaining authorization for construction of new generation capacities for electricity generation from the hydro power plant, HPP "Erenik", located in CA Jasiq, with an installed capacity of 1.86 MW, in Municipality of Junik, Republic of Kosovo.
- On 27.02.2017, ERO received from "Security Team Kabashi K" LLC. the application for admission to the Support Scheme.
- ERO, following the evaluation of relevant evidence and requests attached to the application, and other additional supplementing evidence, concluded that "Hidro Forca" LLC. has proved its suitability for development of the project for construction of new generation capacities for electricity generation from the hydro power plant, HPP "Erenik", located in CA Jasiq, with an installed capacity of 1.86 MW, in Municipality of Junik. ERO also evaluated the request for admission to the Support Scheme, and based on legal provisions mentioned in the introductory section of this decision, decided as in the enacting clause of this Decision.
- **VII.** The Decision shall be issued in Albanian language and published in official languages of the Republic of Kosovo.
- **VIII.** This Decision shall enter into force on the date of approval by the Board and shall be published on FRO's official website.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
