**GUIDELINE ON AMENDMENT OF GUIDELINE ON
LIBERALIZATION OF ELECTRICITY MARKET IN KOSOVO,
AMENDED ON 13 JUNE 2018 AND AMENDED ON 30
OCTOBER 2018**

The Board of Energy Regulatory Office, pursuant to authority given under Article 9, paragraph 1, sub-paragraph 1.7, Article 25, Article 26 of the Law on Energy Regulator (Law no. 05-L-084), in its session held on 28 March 2019, approved the following:

GUIDELINE ON AMENDMENT OF GUIDELINE ON LIBERALIZATION OF ELECTRICITY MARKET IN KOSOVO

Article 1

Purpose

The purpose of this Guideline is the amendment and supplement of Guideline on Liberalization of Electricity Market in Kosovo, issued on 18 January 2017, and amendments of 13 June 2018, as well as amendments of 13 June 2018 and later the amendments of 30 October 2018, approved by the Board of the Regulator.

Article 2

Deregulation of Price for Final Customers

Article 8, paragraph 1, sub-paragraph 1.3 is amended and supplemented with the following text:

- 1.3.1 *Commercial customers of 35 kV voltage level, who do not fulfil the criteria according to Article 37, paragraph 2 of the Law on Electricity, shall be subjected to the criteria and prices of electricity supply market, by 31 March 2020 at the latest.*
- 1.3.2 *Commercial customers of the voltage level 10 kV, who do not fulfil the criteria according to Article 37, paragraph 2 of the Law on Electricity, shall be subjected to criteria and prices of electricity supply market, by 31 March 2021 at the latest*

Article 3

Transitional Provisions

Other provisions of the Guideline on Liberalization of Electricity Market, issued on 17 January 2017, and amendments of 13 June 2018, as well as amendments of 30 October 2018, approved by the Board of the Regulator shall remain unchanged and fully implemented.

Article 4

Fulfilment of Technical Criteria

The Regulator shall undertake concrete legal actions on fulfilment of legal and technical criteria related to the issues mentioned in the Guideline on Market Liberalization.



Article 5 Amendment

1. The Regulator is entitled to amend and modify any provision of the Guideline on Market Liberalization.
2. The procedures for amendment or modification of the Guideline on Market Liberalization shall be the same as for its approval.

Article 6 Interpretation

In case there are uncertainties concerning the provisions of the Guideline on Market Liberalization, the Board shall issue explanatory information.

Article 7 Entry into force

The amendments of the Guideline on Market Liberalization shall enter into force on the date of approval the Board of the Regulator and will be published on ERO's official website.
