**The Board of the Energy Regulatory Office,**

**Based on:**

- Provisions of Article 9, paragraph 1, subparagraph 1.7, Article 15 paragraph 1 subparagraph 1.5, Article 25, Article 26 paragraph 1, sub paragraph 1.2 of the Law on Energy Regulator (Law No. 05/L-084),
- Provisions of Article 10.4 of the Grid Code - General Provisions,
- Provisions of Articles 10 and 11 of the Reporting Manual for the Energy Sector,
- Request for review and approval of the Derogation Report for Grid Code and Market Rules of 20.06.2018 of the Transmission and Market System Operator (KOSTT),

**in the session held on 12.07.2018, issued this:**

## **DECISION**

- I. APPROVING** the request of KOSTT JSC for **Derogations of the provisions of the Grid Code and the Market Rules** as in the annex of this decision.
- II.** Other provisions of the Grid Code and Market Rules remain in force.

## **Reasoning**

- The Energy Regulatory Office (ERO), on 20.06.2018, has received the request of KOSTT JSC for derogation in the implementation of certain provisions of the Grid Code and Market Rules.
- In its request, KOSTT has explained the reasons for the request for derogation of the legal provisions of the Grid Code, related to the reduction of underfrequency according to the Operations Code, and has requested derogation (extension of the deadline for implementation of provisions) of the Grid Code until 31.12.2018 (allowed).
- It has also requested derogation in the implementation of the Market Rules provisions

regarding the allocation and trading of interconnection capacities and for interconnection nominations for a period until KOSTT commences its operation as a Regulatory Area/Regulatory Block (permitted until 31.12.2018).

- After analysing the Derogation Report of the provisions of the Grid Code and the Market Rules, the Board of ERO decided as in the enacting clause of this decision.

**III.** The decision shall be issued and published in the official languages of the Republic of Kosovo.

**IV.** The decision shall enter into force on the date of its approval by the Board of ERO and it will be published on the official ERO website, where the document will be published as well.

**Legal advice:** The party dissatisfied with this decision may address the Competent Court within thirty (30) days from the date of the receipt of the Decision or the date of its publication on ERO's website, whichever occurs last.
