- Application for construction of new generation capacities for self-consumption from solar panels/photovoltaic, located at Llapnasellë, CA Llapnasellë, with an installed capacity of 60 kW, in Municipality of Graçanica, dated on 05.09.2018, prot. No, 398/2018, of "Agro Trade" LLC, having its address at: Graçanicë, Municipality of Graçanica, Republic of Kosovo.

in its session held on 24 September 2018, issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. **APPROVAL** of the request of "Agro Trade" LLC , for construction of new generation capacities for self-consumption, from solar panels/photovoltaic, located at Llapnasellë, with an installed capacity of **60 kW**, in the cadastral area No. 1774/2 CA Llapnasellë, Municipality of Graçanica.
- II. "Agro Trade" LLC, with electric meter registration number DFE-9026287, is **OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, based on the Energy Approval, issued by KEDS JSC.
- IV. "Agro Trade" LLC shall bond a self-production Agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.

Reasoning



- ERO, on 05.09.2018, received from "Agro Trade" LLC the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar panels/photovoltaic, located at Llapsanellë, with an installed capacity of **60 kW**, in the cadastral area No. 1774/2 CA Llapnasellë, Municipality of Graçanica.
- "Agro Trade" LLC along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Energy Approval No. 8325, dated on 13.08.2018, issued by KEDS JSC., and the consent from the Directorate for Urbanization, Planning and Environmental Protection in the Municipality of Graçanica.
- ERO Board, following the analysis of the request of "Agro Trade" LLC, and attached evidence, for construction of new generation capacities for self-consumption from solar panels/photovoltaic, located at Llapnasellë, with an installed capacity of 60 kW, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this Decision, decided as in the enacting clause of this Decision.

V. The Decision is issued and published in official languages of the Republic of Kosovo

VI. This Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
