Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 26, Article 28, paragraph 2, subparagraph 2.11, Article 30 and Article 32 of the Law on Energy Regulatory (Law No.05/L-084);
- Provisions of Article 4 and 6 of the Rule on Licensing of Energy Activities in Kosovo;
- Provisions of Article 37 of the Law No. 02/L-123 on Business Organizations, and Article 17 of the Law No. 04/L-006 on amending and supplementing the Law No. 02/L-123 on Business Organizations, and,
- Application dated 21.12.2017 for licensing the activity of Electricity Wholesale Supply (Trade) from the company “Danske Commodities Kosovo” LLC, Address: Q.Pejton, Str. Mujo Ulqinaku No.5 Ap 4, 10000 Prishtina, Republic of Kosovo,

**in its session held on 13 April 2018, issued the following:**

## **DECISION**

- I. The license for Electricity Wholesale Supply (Trade) from “Danske Commodities Kosovo” LLC, with license number ZRRE/Li\_39/17 is hereby **EXTENDED** for the period from 22.04.2018 to 21.04.2023.

## **Reasoning**

- On 21.12.2017, Energy Regulatory Office (Regulator) received the Application with the relevant evidence for Licensing the activity of Electricity Wholesale Supply (Trade) from “Danske Commodities Kosovo” LLC.
- The Regulator evaluated that the company in question has acted in accordance with Regulator’s instructions/evidences stipulated in Application for Licensing of this activity and has requested additional documents, which were submitted to the Regulator.
- Following the submission of all relevant documents and evidence from the company in question, required in accordance with the application, the Regulator evaluated it, and based on legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.



II. The Electricity Wholesale Supply (Trade) License allows the licensee to carry out the abovementioned electricity activity in Kosovo, in accordance with the License and other applicable legislation.

III. The Decision shall be issued in official languages of Republic of Kosovo.

IV. The Decision shall enter into force on the date of approval by Board of Regulator and shall be published on Regulator's official website.

**Legal Advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
