- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 26, Article 28, paragraph 2, sub-paragraph 2.11, Article 30 and Article 32 of the Law on Energy Regulator (Law No. 05/L-084);
- Provisions of Articles 4 and 6 of the Rule on Licensing of Energy Activities in Kosovo;
- Provisions of Article 37 of Law No. 02/L-123 on Business Organizations, and
- Application dated on 24.10.2017 on licensing of the electricity wholesale supply (trade) activity, submitted by "MCM COMMODITIES" LLC, having its address at: Mother Teresa, 10000, Pristina, Republic of Kosovo,

in its session held on 13 June 2018 issued the following:

DECISION

I. ON EXTENSION of the electricity wholesale supply (trade) license to "MCM COMMODITIES" LLC, with license number ERO/Li 40/17 for the period from 02.05.2018 until 01.05.2023.

Reasoning

Energy Regulatory Office (the Regulator), on 24.10.2017 received from "MCM COMMODITIES" LLC the application with relevant evidence on Licensing of the electricity wholesale supply (trade) activity.





 The Regulator evaluated that the enterprise in question acted in accordance with the instructions from the Regulator as well as requirements/evidence set in the Application for Licensing of this activity, and required additional documents which were submitted at the Regulator.

Following the submission of all relevant documents by the company in question, as well as
evidence required based on the application, the Regulator evaluated it and based on legal
provisions mentioned in the introductory section to this decision, decided as in the enacting
clause to this Decision.

II. The electricity wholesale supply (trade) license allows the licensee to carry out the abovementioned activity of electricity in Kosovo, pursuant to the License and other applicable legislation.

III. The Decision shall be issued in official languages of the Republic of Kosovo.

IV. The Decision shall enter into force on the date of approval by the Board of the Regulator and shall be published on the official website of the Regulator.

Legal Advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
