- Application for construction of new generation capacities for own-consumption from solar panels/photovoltaic, located at Sfaracak i Ulët, with an installed capacity of 10 kW, in Municipality of Vushtria, dated on 18.12.2018, prot. no. 297/2018, of "Initiative for Agriculture Development of Kosovo – IADK", having its address at: Sfaracak i Ulët Village, no.11, Municipality of Vushtria, Republic of Kosovo.

in its session held on 28 January 2019, issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR OWN-CONSUMPTION

- I. **APPROVAL** of the request of the "Initiative for Agriculture Development of Kosovo – IADK", for construction of new generation capacities for own consumption from solar panels/photovoltaic, located at Sfaracak i Ulët, with an installed capacity of 10 kW, in the cadastral areas 70202029-00352-20 CA Sfaracak, Municipality of Vushtria.
- II. The applicant "Initiative for Agriculture Development of Kosovo – IADK", with electric meter registration number DMI-9043660 is **OBLIGED** to submit a request to KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for own-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, based on the Energy Approval, issued by KEDS JSC.
- IV. "Initiative for Agriculture Development of Kosovo – IADK" shall bond an Own-Generation Agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.



Reasoning

- ERO, on 18.12.2018, received from “Initiative for Agriculture Development of Kosovo – IADK” the application on obtaining the decision for construction of new generation capacities for own-consumption, from solar panels/photovoltaic, located at Sfaraçak i Ulët, with an installed capacity of 10 kW, in cadastral areas P-70202029-00352-20 CA Sfaraçak, Municipality of Vushtria.
- “Initiative for Agriculture Development of Kosovo – IADK”, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Energy Approval No. 12741, dated on 15.11.2018, issued by KEDS JSC., and the consent no. 07/353/01-2993, issued by the Directorate for Urbanization, Planning and Environmental Protection in Municipality of Vushtria.
- ERO Board, following the analysis of the request of “Initiative for Agriculture Development of Kosovo – IADK”, and attached evidence, for construction of new generation capacities for own-consumption from solar panels/photovoltaic, located at Sfaraçak i Ulët, with an installed capacity of 10 kW, on the roof of the house, with an installed capacity of **10 kW**, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for own-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this Decision, decided as in the enacting clause of this Decision.

V. The Decision is issued and published in official languages of the Republic of Kosovo

VI. This Decision shall enter into force on the date of approval by the Board and shall be published on ERO’s official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO’s website, whichever occurs last.
