- Decision V_1125_2019, dated on 28 March 2019, on approval of Maximum Allowed Revenues (MAR) for TSO/MO;
- Methodology on Determination of Transmission Use of System Tariffs (TUOS);
- Methodology on Determination of System Operator Tariffs;
- Methodology on Determination of Market Operator Tariffs; and
- Request/application of KOSTT JSC., on approval of TSO/MO Tariffs within electricity tariffs review, submitted on 10 April 2019,

in the session held on 16 April 2019, issued the following:

DECISION

- I. APPROVAL- of transmission, market and system operator tariffs (KOSTT JSC.) for the period 1 April 2019- 31 March 2020.
- II. The tariff structure for KOSTT JSC., which shall be implemented starting from 1 April 2019 is given in the following table of this Decision:

REASONING

- ✚ ERO, on 10 April 2019, received from KOSTT JSC the request/application for TSO/MO Tariffs.
- ✚ ERO, for determination of TSO/MO Tariffs, considered the following documents prepared, issued and published on the official website of ERO:
 - Consultation Paper- Annual Adjustments for Maximum Allowed Revenues for KOSTT JSC., (April 2019- March 2020), published on February 2019; and
 - Final Report on TSO/MO Maximum Allowed Revenues, as well as Response to Comments (April 2019- March 2020), published on April 2019.
 - ERO Board, following the review and analysis of relevant reports and the review of comments received by parties, as well as based on legal provisions mentioned in the introductory section to this Decision, has decided as in the enacting clause to this Decision.

III. The Decision is issued and published in official languages of the Republic of Kosovo.

IV. The Decision shall enter into force on the date of approval by ERO Board, and shall be implemented by KOSTT JSC, starting from 1 April 2019, until the regular tariff review.

Legal Advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
