Based on:

- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 and Article 43, paragraph 1 of the Law on Energy Regulator (No. 05/L-084)
- Article 25 of the Rule No. 11/2017 on the Authorization Procedure for Construction of New Generation Capacities based on Renewable Energy Sources;
- Article 18, 19 and 20 of the Rule No. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for own-consumption from solar panels/ photovoltaic, on the facility constructed in the village Dyz, CA Dyz, with an installed capacity of **25 kW**, in Municipality of Podujeva, dated on 16.05.2019, with prot no. 300/2019 of the applicant Sami Uka (Dyzi Berry Fruits) , having its address at: Village "Dyz", Municipality of Podujeva, Republic of Kosovo,

in the session held on 05 June 2019 issued the following

DECISION

FOR CONSTRUCTION OF GENERATING CAPACITIES FOR OWN-CONSUMPTION

- I. **APPROVAL** of the request of the applicant Sami Uka (Dyzi Berry Fruits) for construction of new generation capacities for own-consumption from solar panels/photovoltaic, in village Dyz, CA Dyz, with an installed capacity of **25 kW**, to be placed over the facility, Municipality of Podujeva.
- II. The applicant Sami Uka (Dyzi Berry Fruits), with the registered code of the electric meter DPR-90138425, is **OBLIGED** to submit to KEDS JSC, a request for technical admission of the energy facility, following the construction of new generation capacities for own-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, in accordance with the Electro-energetic consent, issued by KEDS JSC.
- IV. The applicant Sami Uka shall bond an Agreement for own-consumption with the supplier, with whom it has an electricity supply contract, following the confirmation of technical admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

Reasoning



- ERO, on 16.05.2019, received from the applicant Sami Uka (Dyzi Berry Fruits), the application for obtaining the Decision on construction of new generation capacities for own-consumption from solar panels/photovoltaic, over the facility constructed in village Dyz, CA Dyz, with an installed capacity of **25 kW**, customer code DPR-90138425, Municipality of Podujeva.
- The applicant, along with the application also attached evidence from KEDS for annual consumption of electricity, evaluation of annual production in kW/h of the installed equipment, Electro-energetic consent No. 2084, dated on 03.04.2019, issued by KEDS JSC, the executing project and Consent dated on 03.07.2018, issued by Directorate of Public Services, Protection and Rescue, Municipality of Podujeva.
- ERO Board, following the analysis of the request of the applicant Sami Uka (Dyzi Berry Fruits), and attached evidence for construction of new generation capacities for own-consumption from solar panels/photovoltaic in the roof of the individual house, constructed in village Dyz, CA Dyz, with an installed capacity of **25 kW**, evaluated them and considered that the relevant evidence for issuance of the decision for construction of new generation capacities have been fulfilled, therefore based on the legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.

V. The Decision is issued and published in the official languages of the Republic of Kosovo.

VI. The Decision shall enter into force on the date of approval by the Board and will be published on the electronic website of ERO.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
