- Article 18, 19 and 20 of the Rule No. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for own-consumption from solar panels/ photovoltaic, in the facility constructed in the cadastral area No. 1601-1, CA Izvor, with an installed capacity of **5 kW**, in Municipality of Novobërda, dated on 16.05.2019, prot. not. 301/2019, of the applicant Besiana G LLC, having its address at: village "Izvor", Municipality of Novobërda, Republic of Kosovo,

in the session held on 05 June 2019 issued the following

## DECISION

### FOR CONSTRUCTION OF GENERATING CAPACITIES FOR OWN-CONSUMPTION

- I. **APPROVAL** of the request of the applicant Besiana G LLC for construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the cadastral area No. 1601-1, CA Izvor, with an installed capacity of **5 kW**, to be placed over the facility, Municipality of Novobërda.
- II. The applicant Besiana G LLC, with the registered code of the electric meter DPR-90049616, is **OBLIGED** to submit to KEDS JSC, a request for technical admission of the energy facility, following the construction of new generation capacities for own-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, in accordance with the Electro-energetic consent, issued by KEDS JSC.
- IV. The applicant Besiana G LLC shall bond an Agreement for own-consumption with the supplier with whom it has an electricity supply contract, following the confirmation of technical admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

## Reasoning



- ERO, on 16.05.2019, received from the applicant Besiana G LLC, the application for obtaining the Decision on construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the cadastral area No. 1601-1, CA Izvor, with an installed capacity of **5 kW**, that will be placed over the facility, customer code DPR-90049616, Municipality of Novobërda.
- The applicant, along with the application also attached evidence from KEDS for annual consumption of electricity, evaluation for annual production in kW/h of the installed equipment, Electro-energetic consent No. 1784, dated on 20.03.2019, issued by KEDS JSC, the executing project and Consent No. 09-248, dated on 10.05.2019, issued by Directorate for Planning, Urbanization, Cadastre and Environmental Protection, Municipality of Novobërda.
- ERO Board, following the analysis of the request of the applicant Besiana G LLC, and attached evidence for construction of new generation capacities for own-consumption from solar panels/photovoltaic in the roof of the individual house, constructed in the cadastral area No. 1601-1, CA Izvor, with an installed capacity of **5 kW**,, evaluated them and considered that the relevant evidence for issuance of the decision for construction of new generation capacities have been fulfilled, therefore based on the legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.

**V.** The Decision is issued and published in the official languages of the Republic of Kosovo.

**VI.** The Decision shall enter into force on the date of approval by the Board and will be published on the electronic website of ERO.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
