Based on:

- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 and Article 43, paragraph 1 of the Law on Energy Regulator (No. 05/L-084)
- Article 25 of the Rule No. 11/2017 on Authorization Procedure for Construction of New Generation Capacities based on Renewable Energy Sources;
- Articles 18, 19 and 20 of the Rule No. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for own-consumption from solar panels/ photovoltaic, in the facility constructed in the cadastral area No. 1055-1, CA Prelez, with an installed capacity of **100 kW**, in Municipality of Ferizaj, dated on 17.10.2019, prot. no. 336/2019, of the applicant "Ballkan Petrol" LLC, having its address at: "Gërlic" Village, Municipality of Ferizaj, Republic of Kosovo,

in the session held on 27 November 2019 issued the following

## DECISION

### FOR CONSTRUCTION OF GENERATING CAPACITIES FOR OWN-CONSUMPTION

- I. **APPROVAL** of the request of applicant "BALLKAN PETROL" LLC for construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the facility constructed in accordance with the Construction Permit No. 04-351/02-0080529/18, in the cadastral area No. 1055-1, CA Prelez i Jerlive, with an installed capacity of **100 kW**, to be placed over the facility, Municipality of Ferizaj.
- II. The applicant "BALLKAN PETROL" LLC, with the registered code of the electric meter DFE-9018568, is **OBLIGED** to submit to KEDS JSC, a request for technical admission of the energy facility, following the construction of new generation capacities for own-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, in accordance with the Electro-energetic consent, issued by KEDS JSC.
- IV. The applicant "BALLKAN PETROL" LLC shall bond an Agreement for own-consumption with the supplier with whom it has an electricity supply contract, following the confirmation of technical admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.



## Reasoning

- ERO, on 17.10.2019, received from the applicant “Ballkan Petrol” LLC, the application for obtaining the Decision on construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the cadastral area No. 1055-1, CA Prelez i Jerlive, with an installed capacity of **100 kW**, customer code DFE -9018568 that will be placed over the facility, Municipality of Ferizaj.
  - The applicant, along with the application also attached evidence from KEDS for annual consumption of electricity, evaluation for annual production in kW/h of the installed equipment, Electro-energetic consent No. 6846, dated on 07.10.2019, issued by KEDS JSC and the Consent No.04-352/01-0009948/19, dated on 22.02.2019, issued by Directorate for Urbanization and Environmental, Municipality of Ferizaj.
  - ERO Board, following the analysis of the request of the applicant “BALLKAN PETROL” LLC, and attached evidence for construction of new generation capacities for own-consumption from solar panels/photovoltaic on the roof of the facility, constructed in the cadastral area No. 1055-1, CA Prelez i Jerlive, with an installed capacity of **100 kW**, Municipality of Ferizaj evaluated them and considered that the relevant evidence for issuance of the decision for construction of new generation capacities for own-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.
- V.** The Decision is issued and published in the official languages of the Republic of Kosovo.
- VI.** The Decision shall enter into force on the date of approval by the Board and will be published on the electronic website of ERO.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO’s website, whichever occurs last.
