Based on:

- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 and Article 43, paragraph 1 of the Law on Energy Regulator (No. 05/L-084)
- Article 25 of the Rule No. 11/2017 on Authorization Procedure for Construction of New Generation Capacities based on Renewable Energy Sources;
- Articles 18, 19 and 20 of the Rule No. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for own-consumption from solar panels/ photovoltaic, placed in the residential facility, with an installed capacity of **2 kW**, in Pagarushë village, Municipality of Malisheva, dated on 11.11.2019, prot. No. 593/2019, of the applicant Nexhat Kryeziu, having its address at: "Pagarushë" village, Municipality of Malisheva, Republic of Kosovo,

in the session held on 27 November 2019 issued the following

DECISION

FOR CONSTRUCTION OF GENERATING CAPACITIES FOR OWN-CONSUMPTION

- I. **APPROVAL** of the request of applicant Nexhat Kryeziu for construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the residential facility, Pagarushë village, with an installed capacity of **2 kW**, that will be placed over the residential facility, in Municipality of Malisheva.
- II. The applicant Nexhat Kryeziu, with the registered code of the electric meter DGJ-9044697, is **OBLIGED** to submit to KEDS JSC, a request for technical admission of the energy facility, following the construction of new generation capacities for own-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, in accordance with the Electro-energetic consent, issued by KEDS JSC.
- IV. The applicant Nexhat Kryeziu shall bond an Agreement for own-consumption with the supplier with whom it has an electricity supply contract, following the confirmation of technical admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

Reasoning



- ERO, on 11.11.2019, received from the applicant Nexhat Kryeziu, the application for obtaining the Decision on construction of new generation capacities for own-consumption from solar panels/photovoltaic, in the residential facility, Pagarushë village, with an installed capacity of **2 kW**, to be placed over the facility, customer code DGJ -90446979, in Municipality of Malisheva.
 - The applicant, along with the application also attached evidence from KEDS for annual consumption of electricity, evaluation for annual production in kW/h of the installed equipment, Electro-energetic consent No. 6951, dated on 11.10.2019, issued by KEDS JSC, the technical project and the response No. 05/513 dated on 07.11.2019, issued by Directorate for Urbanization of Municipality of Malisheva.
 - ERO Board, following the analysis of the request of the applicant Nexhat Kryeziu, and attached evidence for construction of new generation capacities for own-consumption from solar panels/photovoltaic, to be placed over the residential facility in Pagarushë village, with an installed capacity of **2 kW**, customer code DGJ- 90446979, evaluated them and considered that the relevant evidence for issuance of decision for construction of new generation capacities for own-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory section of this Decision, decided as in the enacting clause of this Decision.
- V.** The Decision is issued and published in the official languages of the Republic of Kosovo.
- VI.** The Decision shall enter into force on the date of approval by the Board and will be published on the electronic website of ERO.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
