# Role of ERO

Regulation plays an important role in economical development facilitating the appropriate institutional and organizational structure that needs to be in place in order to attract the massive private investments that are required to exploit rational natural resources.

ERO

The main task of ERO is to create conditions for reliable, safe and environmentally sound supply of energy, and to promote, establish and protect a competitive energy market based on principles of objectivity, transparency and non-discrimination in Kosovo.



Pursuant to Primary and Secondary Legislation (Law on the Energy Regulator, Rule on Licensing of Energy Activities in Kosova, Rule on General Conditions for Rule Energy Supply, on Principles of Calculation of Tariffs ect.) ERO has the powers, duties and functions to develop the conditions for issuina licenses to carry out energy

activities, the procedures for granting permits for construction of new generating capacity, the criteria for regulating prices, and the conditions of energy supply.

•Licensing of all Energy activities in Kosovo and developing the procedures for compliance monitoring of the licenses.
