



Board of the Energy Regulatory Office following:

1. Provisions of Article 15.2 and Article 47 of the Law on Energy Regulator amended by Law No.03/L-080”;
2. Provisions of the “Rule on Tariff Calculation Principles in the Power Sector (Pricing Rule)”;
3. Provisions of the “Tariff Methodology in the Power Sector”;
4. KOSTT JSC request on review of transmission tariffs dated Feb. 18th, 2009,

In its session held on April 15th, 2009 adopted this:

DECISION

- I. Transmission tariffs and charges that will be applied by KOSTT JSC from April 1st, 2009 are **APPROVED.**
1. The decision is based on the documents issued and published by ERO in its official web-page:
 - Third Electricity Tariff Review 2009 – Consultation paper and Consultation Paper Annex on KOSTT, issued on March 3rd, 2009 and March 5th, 2009; and
 - Electricity Tariff Review 2009 – Response to comments on the Consultation Paper issued on April 2nd, 2009.
2. The tariff structure and charge for KOSTT JSC that should be applied starting from April 1st, 2009 is provided in details in the following table.

4. This decision shall be issued in Albanian language and translated into Serbian and English. In the event of any discrepancy between different versions, the version in Albanian shall prevail.
5. This decision enters into force in the date of its issue, when it is also published in the ERO's official webpage.
6. Unsatisfied party may file an appeal against this decision before the court of respective jurisdiction within 14 days since the date of its entry into force.
