- Article 4, Article 5, Article 6 paragraph 1, Article 8, Article 9, Article 11 and Article 14 of the Rule on Support Scheme;
- Administrative Instruction No. 01/2013 on RES Targets, issued by the Ministry of Economic Development;
- Decision No. V-673-2014, dated 23 December 2014 on determination of the Feed-in tariffs for generation of electricity from Renewable Energy Sources;
- Decision No. V-535-2013, dated 02 May 2013 on issuing the Decision on Notification for Preliminary Authorization for "Edelweiss Energy" L.L.C. company, for the construction of new electricity generation capacity from Water, HPP "Ura e Shenjt", with an installed capacity of 6.5 MW, in Drini i Bardhë River, location "Ura e Shenjt", Municipality of Rahovec, and
- Application/Request for Admission to the Support Scheme for HPP "Ura e Shenjt", with an installed capacity of 6.5 MW, in Drini i Bardhë River, location "Ura e Shenjt", Municipality of Rahovec, dated 22 January 2015, submitted by "Edelweiss Energy" L.L.C. company, having its address at: "Ilir Konushevci" Str., no. 119 – 10000, Municipality of Prishtina, Republic of Kosovo,

in its session held on 20 February 2015, issued the following:

DECISION

- I. The request of "Edelweiss Energy" LLC. company is hereby **APPROVED** and the operator for generation of electricity from Water is **ADMITTED** to the Support Scheme, for the HPP "Ura e Shenjt", with an installed capacity of 6.5 MW, in Drini i Bardhë River, location "Ura e Shenjt", Municipality of Rahovec.
- II. The Feed-in Tariff for generation of electricity from Renewable Energy Sources is hereby guaranteed to the Generation Operator referred to in item I of the enacting clause, by default.
- III. Power Purchase Agreement with the Public Supplier is guaranteed to the Generation Operator referred to in item I of the enacting clause, for a duration of 10 years, and it shall be concluded at least thirty (30) days before the date of commencement of generation operation.



Reasoning

- On 22 January 2015, ERO received from the “**Edelweiss Energy**” LLC. company, the application for admission to the Support Scheme on generation of electricity from Water, HPP "Ura e Shenjt", with an installed capacity of 6.5 MW, in Drini i Bardhë River, location “Ura e Shenjt”, Municipality of Rahovec.
 - On 02 May 2013, the ERO Board issued to the "Edelweiss Energy" LLC. company the Decision V-535-2013 on Notification for Preliminary Authorization for construction of new electricity generation capacities.
 - ERO, following the assessment and analysis of the request/application for admission to the Support Scheme, pursuant to the legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause of this Decision.
- IV.** This decision shall form an integral part of the Decision V-535-2013, dated 02 May 2013, issued by the ERO Board, whereby the Decision on Notification for Preliminary Authorization was issued to the "Edelweiss Energy" LLC. company for construction of new electricity generation capacities, pursuant to the applicable legislation.
- V.** The Decision shall be issued in Albanian language and will be translated into Serbian language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- VI.** The Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
