- Decision No. V-492-2012, dated 28 December 2012 on issuing the Decision on Notification for Preliminary Authorization for the "Drini i Bardhë" JCS. company, in Drini i Bardhë River, HPP Dobrushtë, location: Dobrushtë Village, with an installed capacity of 9.96 MW, Municipality of Prizren, and
- Application/Request for Admission to the Support Scheme for the HPP Dobrushtë, location: Dobrushtë Village, with an installed capacity of 9.96 MW, Municipality of Prizren, dated 29.01.2015, submitted by the "Drini i Bardhë" JSC. company, having its address at: "Vetim Shala" Str., no 4, MA Prizren, Republic of Kosovo,

in its session held on 20 February 2015, issued the following:

DECISION

- I. The request of "Drini i Bardhë" JSC. company is hereby APPROVED and the operator for generation of electricity from Water is ADMITTED to the Support Scheme, for the HPP Dobrushtë, location: Dobrushtë Village, with an installed capacity of 9.96 MW, Municipality of Prizren.
- II. The Feed-in Tariff for generation of electricity from Renewable Energy Sources is hereby guaranteed to the Generation Operator referred to in item I of the enacting clause, by default.
- III. Power Purchase Agreement with the Public Supplier is guaranteed to the Generation Operator referred to in item I of the enacting clause, for a duration of 10 years, and it shall be concluded at least thirty (30) days before the date of commencement of generation operation.



Reasoning

- On 03 February 2015, ERO received from the "Drini i Bardhë" JSC. company, the application for admission to the Support Scheme on generation of electricity from Water, for the HPP Dobrushtë, location: Dobrushtë Village, with an installed capacity of 9.96 MW, Municipality of Prizren.
- On 28 December 2012, the ERO Board issued to the "Drini i Bardhë" JSC. company the Decision V-492-2012 on Notification for Preliminary Authorization for construction of new electricity generation capacities.
- ERO, following the assessment and analysis of the request/application for admission to the Support Scheme, pursuant to the legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause of this Decision.
- **IV.** This decision shall form an integral part of the Decision V-492-2012, dated 28 June 2012, issued by the ERO Board, whereby the Decision on Notification for Preliminary Authorization was issued to the "Drini i Bardhë" LLC. company for construction of new electricity generation capacities, pursuant to the applicable legislation.
- **V.** The Decision shall be issued in Albanian language and will be translated into Serbian language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- VI. The Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
