- Request of the Transmission System and Market Operator (KOSTT JSC.), dated 05 February 2015 for review and approval of documents: Market Rules Procedure,

in its session held on 20 February 2015, issued the following:

DECISION

I. On **APPROVING** the following Market Rules Procedures:

- *Market Rules Procedure on Meter Reading, Validation and Estimation;*
- *Market Rules Procedures on Meter Adjustments;*
- *Market Rules Procedures on Metered Energy Allocation; and*
- *Market Rules Procedure on Security Cover.*

Reasoning

On 05 February 2015, the Energy Regulatory Office (ERO) received the request for approval of the final version of documents: **Market Rules Procedures** of KOSTT JSC. The Documents have been prepared based on Market Rules, and shall be considered as a part of Market Rules.

Initially, KOSTT submitted the documents for review on 20 June 2014. In the meantime, ERO provided its comments, in writing and directly during the meetings held with the representatives of KOSTT, wherefrom the comments were included or the issues raised were clarified, and eventually the documents took the proper form for approval.

Therefore, on 05 February 2015, KOSTT submitted for approval with the ERO the final version of the following documents:

- Market Rules Procedure on Meter Reading, Validation and Estimation;
- Market Rules Procedures on Meter Adjustments;

- Market Rules Procedures on Metered Energy Allocation; and
- Market Rules Procedure on Security Cover.

As part of the Market Rules, these procedures are of a special importance and complete the Market Rules and facilitate the implementation thereof. As a result, ERO has carefully analyzed the above mentioned procedures and considers that, as documents, they meet the criteria for approval, and taking into consideration the legal provisions mentioned in the introductory section of the decision, it has decided as in the enacting clause of this decision, thus approving the **Market Rules Procedures**.

II. The Decision shall be issued in Albanian language and will be translated into Serbian and English. In case of any discrepancy between the versions, the Albanian version shall prevail.

III. The Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website, wherein the Market Rules document will be published as well.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
