- Administrative Instruction No. 01/2013 on RES Targets, issued by the Ministry of Economic Development;
- Decision No. V-673-2014, dated 23 December 2014 on determination of the Feed-in tariffs for generation of electricity from Renewable Energy Sources;
- Decision No. V-497-2013, dated 23 January 2013, on issuing the Decision on Notification for Preliminary Authorization to the N.T.SH. "RIMED" Company, for construction of new generation capacities for generation of electricity from Water, HPP Kuqishtë, with an installed capacity of 3.1 MW, in "Lumëbardhi i Pejës" River, Kuqishtë location, Municipality of Peja, and
- Application/Request for Admission to the Support Scheme on construction of new generation capacities for generation of electricity from Water, HPP Kuqishtë, with an installed capacity of 3.1 MW, in "Lumëbardhi i Pejës" River, Kuqishtë location, Municipality of Peja, dated 26.02.2015, submitted by N.T.SH. "RIMED" Company, having its address at: Prishtina – Ferizaj highway, "Laplja Selo", Municipality of Graçanica, Republic of Kosovo,

in its session held on 10 April 2015, issued the following:

DECISION

- I. The request of N.T.SH. "RIMED" Company, is hereby **APPROVED** and the operator for generation of electricity from Water, HPP Kuqishtë, with an installed capacity of 3.1 MW, in "Lumëbardhi i Pejës" River, Kuqishtë location, Municipality of Peja is **ADMITTED** to the Support Scheme.
- II. The Feed-in Tariff for generation of electricity from Renewable Energy Sources is hereby guaranteed to the Generation Operator referred to in item I of the enacting clause, by default.
- III. Power Purchase Agreement with the Public Supplier is guaranteed to the Generation Operator referred to in item I of the enacting clause, for a duration of 10 years, and it shall be concluded at least thirty (30) days before the date of commencement of generation operation.



Reasoning

- On 26 February 2015, ERO received from N.T.SH. "RIMED" Company, the application for admission to the Support Scheme on generation of electricity from Water, HPP Kuqishtë, with an installed capacity of 3.1 MW, in "Lumëbardhi i Pejës" River, Kuqishtë location, Municipality of Peja.
 - On 23 January 2013, the ERO Board issued to the N.T.SH. "RIMED" Company, the Decision V-497-2013 on Notification for Preliminary Authorization for construction of new generation capacities for generation of electricity.
 - ERO, following the assessment and analysis of the request/application for admission to the Support Scheme, pursuant to the legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause of this Decision.
- IV.** This decision shall form an integral part of the Decision V-497-2013, dated 23 January 2013, issued by the ERO Board, whereby the Decision on Notification for Preliminary Authorization was issued, and the Decision V-707-2015, dated 20 February 2015, for extension of the time-limit of validity of the Decision on Notification for Preliminary Authorization until 23 July 2015, of the N.T.SH. "RIMED" Company, for construction of new generation capacities for generation of electricity, pursuant to the applicable legislation.
- V.** The Decision shall be issued in Albanian language and will be translated into Serbian language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- VI.** This Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
