- Application for Licensing of Electricity Import and Export Activity submitted to ERO on 27 March 2015 by "EVN TRADING" L.L.C. Enterprise, having its address at: Mustafë Kruja, No. 14, Prishtina, Republic of Kosovo.

**in its session held on 15 June 2015, issued the following:**

## **DECISION**

- I. On ISSUING** the Electricity Import and Export License to "EVN TRADING" L.L.C. Enterprise, license number ZRRE/Li\_42/15, for the time period from **15 June 2015** until **15 June 2020**.

## **Reasoning**

- Energy Regulatory Office (ERO) received on 27 March 2015 from the "EVN TRADING" L.L.C. Enterprise the Application with relevant evidence for Licensing of the Electricity Import and Export Activity.
  - ERO considered that the enterprise in question has acted in compliance with the ERO guidelines and requirements/evidence foreseen in the Application for Licensing of the Electricity Import and Export Activity.
  - Following the submission of all documents and evidence requested under the application by the enterprise in question, ERO has assessed them and based on the legal provisions mentioned in the introductory section of this decision, decided as in the enacting clause of this decision.
- II.** The Electricity Import and Export License allows the licensee to perform the above-mentioned activity of electricity in Kosovo with a capacity of up to 400 MW, in compliance with the License and other applicable legislation.

**III.** The Decision shall be issued in Albanian language and will be translated into Serbian and English. In case of any discrepancy between the versions, the Albanian version shall prevail.

**IV.** This Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
