- Administrative Instruction No. 01/2013 on RES Targets, issued by the Ministry of Economic Development.
- Decision No. V-673-2014, dated 23 December 2014 on determination of the Feed-in tariffs for generation of electricity from Renewable Energy Sources;
- Decision No. V-402-2012, dated 15 June 2012, on granting of Final Authorisation to "KelKos Energy" LLC. Company for construction of new generation capacities for generation of electricity from Water, with an installed capacity of 17.6 MW, consisting of two (2) generation units, to be installed in the following locations: HPP Belaja with a capacity of 9.2 MW and HPP Deçan with an installed capacity of 8.4 MW, in the Municipality of Deçan, and
- Application/Request for admission to the Support Scheme for the HPP Deçan, with an installed capacity of 8.4 MW, dated 13.07.2015, submitted by "KelKos Energy" LLC Company, having its address at: "Sali Ceku" Str., Gogaj Building, No. 14 51000, Municipality of Deçan, Republic of Kosovo,

in its session held on 16 June 2015, issued the following:

## DECISION

- I. The request of "KelKos Energy" LLC Company, is hereby APPROVED and the operator for generation of electricity from Water, for HPP Deçan, with an installed capacity of 8.4 MW, in "Lumëbardhi i Deçanit" River, Municipality of Deçan, is ADMITTED to the Support Scheme.
- **II.** The Feed-in Tariff for generation of electricity from Renewable Energy Sources is hereby guaranteed to the Generation Operator referred to in item I of the enacting clause, by default.
- III. Power Purchase Agreement with the Public Supplier is guaranteed to the Generation Operator referred to in item I of the enacting clause, for a duration of 10 years, and it shall be concluded at least thirty (30) days before the date of commencement of generation operation.



## Reasoning

- On 13 July 2015, ERO received from "KelKos Energy" LLC Company, the application for admission to the Support Scheme on generation of electricity from Water, for HPP Deçan, with an installed capacity of 8.4 MW, in "Lumëbardhi i Deçanit" River, Municipality of Deçan.
- On 15 June 2012, the ERO Board issued to the "KelKos Energy" LLC Company the Decision V-402-2012 on Final Authorization for construction of new electricity generation capacities.
- ERO, following the assessment and analysis of the request/application for admission to the Support Scheme, pursuant to the legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause of this Decision.
- IV. This decision shall form an integral part of the Decision V-402-2012, dated 15 June 2012, issued by the ERO Board, whereby the Decision on Final Authorisation was issued to the "KelKos Energy" LLC Company for construction of new electricity generation capacities, pursuant to the applicable legislation.
- **V.** The Decision shall be issued in Albanian language and will be translated into Serbian language. In case of any discrepancy between the versions, the Albanian version shall prevail.
- VI. This Decision shall enter into force on the date of approval by the Board and will be published in the ERO's official website.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute with the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication in the ERO website, whichever occurs last.
