The Board of the Energy Regulatory Office,

Based on:

- Provisions of Article 8, paragraph 1, sub-paragraph 1.6, Article 14, paragraph 2, sub-paragraph 2.16, Article 18, Article 22 and Article 23 of the Law on Energy Regulator (Law No. 03/L-185);
- Provisions of Article 4 and Article 6 of the Rule on Fees, and
- Provisions of the Law on the Budget of the Republic of Kosovo for 2012 (Law No. 04/L-079), and the Law on Amending and Supplementing the Law No. 04/L-079 on the Budget of the Republic of Kosovo for 2012 (Law No. 04/L-128)

in the session held on 01 October 2012, issued the following:

DECISION

- I. All the licensees in the Energy Regulatory Office (ERO) shall be **RELEASED** from the annual fee payment for the period from 01 March 2012 to 31 October 2012.

Justification

1. The Energy Regulatory Office collects fees by the licensed enterprises and other activities, which are revenues dedicated to the ERO. Annual fees and other fees are determined by the Law on Energy Regulator and Rule on Fees.
2. Annual fees are collected in order to facilitate financial sustainability of ERO in order to operate cost-effectively.
3. Energy Regulatory Office after achieving its financial sustainability and in order to harmonize the "The Revenues with the Budget of the Energy Regulatory Office for 2012", releases the licensee from paying the annual licensing fee in accordance with the Law on Energy Regulator, as in the enacting provisions of this decision, because:
 - 3.1. The revenues collected so far pursuant to Article 7 and 8 of the Rule on Fees fulfill the planned budget of the ERO for 2012.



3.2. Release from payment of this fee for this period, for the enterprises that produce electricity and thermal energy will be reflected in the determination of Allowed Revenues for the next tariff review period (2013 year), through coordination of Allowed Revenues.

- II. The Decision shall be issued in Albanian language and will be translated into Serbian and English. In the event of any discrepancy between the versions, the Albanian version shall prevail.
- III. This Decision shall enter into force on the date of approval by the Board of ERO and shall be published in the official website of ERO.

Legal Advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of the Decision or the date of its publication in the ERO website, whichever occurs last.
