The Board of the Energy Regulatory Office,

Based on:

- The provisions of Article 8, paragraph 1, sub-paragraph 1.6, Article 14, paragraph 2, sub-paragraph 2.2, Article 25 and Article 34, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator (Law No. 03/L-185);
- The provisions of Article 2, paragraph 3, subparagraph 3.1 and Article 33 of the Rule on Licensing of Energy Activities in Kosovo,

in the session held on 12 October 2012, issued the following:

DECISION

- I. IT IS MODIFIED the License for Public Supply of district heating (with conditions)** given to the District Heating Termokos JSC – with license number ZRRE/Li_12/06.
- II.** The modified license (hereinafter "License for Public Supply of District Heating ") with license number ZRRE/Li_12/12 shall enter into force on the date of issuance of this decision and will be valid until the date **04.10.2036**. The Publicly Owned Enterprise "Termokos" JSC is obliged to implement all provisions of the modified license.

Justification

- The Energy Regulatory Office (ERO) in December 2011 has initiated the procedure for modification of license for public supply of district heating for the Publicly Owned Enterprise "Termokos" JSC, issued by the Board of ERO dated 04.10.2006. Modification has been initiated in accordance with Article 34 of the Law on Energy Regulator, as a result of amendment of the laws in the energy sector.
 - On January 27, 2012 ERO has published on its website the abovementioned draft- license for comments from the interested parties. ERO has taken into account also the comments of interested parties and finally has harmonized the provisions of this license with primary and secondary legislation in the energy sector.
 - Taking into account the above and based on the legal provisions mentioned in the introduction of this decision, the ERO has decided as in the enacting provision of this decision.
- III.** The Decision shall be issued in Albanian language and will be translated into Serbian and English. In the event of any discrepancy between the versions, the Albanian version shall prevail.



IV. This Decision shall enter into force on the date of approval by the Board of ERO and shall be published in the official website of ERO.

Legal Advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of the Decision or the date of its publication in the ERO website, whichever occurs last.
