- Article 8 paragraph 1 subparagraph 1.6, Article 14 paragraph 2 subparagraph 2.6 and 2.16, Articles 25 and 43 of the Law on Energy Regulator No. 03/L-185;
- Rule on Distribution System Operator Pricing (DSO Pricing Rule), and
- Application of KEDS-DSO submitted under the Eighth Electricity Tariff Review (ETR8) accompanied with relevant explanatory documentation.
- Decision No. V_634_2014 on the Maximum Allowed Revenues (MAR) for DSO;
- Methodology of Charges on Use of the Distribution System; and
- Application dated 26 June 2014 of KEDS submitted to ERO on approval of regulated charges of the Distribution System Operator;

Following review of relevant submissions and documentation and based on abovementioned legal provisions, in its meeting held on 30 June 2014, adopted the following:

DECISION

I. APPROVING tariffs and charges to be implemented by the Distribution System Operator (KEDS) for the relevant tariff year or ETR8, effective from 1 April 2014.

JUSTIFICATION

- The Energy Regulatory Office (ERO) received from the Distribution System Operator (KEDS) on 26 June, the application for review of regulated charges for the Distribution System Operator (DSO);
- In order to set up the electricity retail tariffs for regulated customers, ERO took into consideration adopted and published documents in its website as well as clarification meetings held with the Licensees during February-May 2014. These documents are as follows:
 - Final Report Calculation of Wholesale Electricity Costs published on 24 June 2014;
 - Final Report Calculations of DSO MAR published on 24 June 2014; and
 - Response to KEDS Comments Calculations of Maximum Allowed Revenues published on 24 June 2014.



- **II.** Based on legal provisions stated in the introductory part of this Decision and following review of all respective notes and documents, the Board of ERO decided as in enacting clause of this decision.
- III. The structure of charges for DSO to be applied effective from 1 April 2014, respectively in the relevant tariff year ETR8, has been provided in the following table:

- **IV.** This Decision shall enter into force on the date of its approval by the ERO Board and shall be published in the official website of ERO.
- **V.** The Decision shall be issued in Albanian language and will be translated into Serbian and English. In the event of any discrepancy between the versions, the version in Albanian shall prevail.

Legal Remedy: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of the Decision or the date of its publication in the ERO website, whichever occurs last.
