- Article 25 of the Rule No.11/2017 on the Authorization Procedure for Construction of New Capacities based on Renewable Energy Sources;
- Articles 18, 19 and 20 of the Rule No.10/2017 on the Support Scheme for the RES Generators, and
- Application for construction of new generation capacities for self-consumption from solar panels/photovoltaic, located at the cadastral area No. 01882-0 ZK Obiliq, with an installed capacity of **16.32 kW**, in Municipality of Obiliq, dated on 03.06.2020, prot. no. 228/20, of the applicant "Municipality of Obiliq", having its address at Street Adem Jashari, Municipality of Obiliq, Republic of Kosovo,

in the session held on 23 June 2020 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request of the applicant "Municipality of Obiliq", for construction of new generating capacities for self-consumption from solar/photovoltaic panels, in the cadastral area No.01882-0, CA Obiliq, with an installed capacity of 16.32 kW, in Municipality of Obiliq.
- **II.** The applicant "Municipality of Obiliq", with registered figure of electric meter DPR- 90127519 is hereby **OBLIGED** that after the construction of new generating capacities for self-consumption, to submit a request to KEDS JSC, for technical acceptance of the energy facility.
- **III.** ERO will consider the project finalized from the date of technical acceptance according to the Electricity Consent issued by KEDS JSC.
- **IV.** The applicant "Municipality of Obiliq" will enter into a Self-Generation Agreement with the supplier with whom it has a contract for electricity supply, following the confirmation of technical acceptance from KEDS JSC, in accordance with Article 18, paragraphs 1 and 2 of Rule no. 10/2017 on the Support Scheme.

Reasoning





- ERO, on 03.06.2020, from the applicant "Municipality of Obiliq", has received the application for decision making for construction of new generating capacities for self-consumption from solar/photovoltaic panels, in the cadastral parcel no. 01882-0 CA Obiliq, with an installed capacity of 16.32 kW customer code DPR- 90127519 to be placed over the facility, in Municipality of Obiliq.
- The applicant, along with the application, attached the evidence from KEDS for the annual electricity consumption, the assessment for the annual production in kW/h of the installed equipment, the electricity consent no. 3794, dated on 02.06.2020, issued by KEDS JSC, and Consent No. VI -331, dated on 18.05.2020, issued by the Directorate for Municipal Services and Emergency of Municipality of Obiliq.
- ERO Board, following the analysis of the request of the applicant "Municipality of Obiliq", and the attached evidence, for construction of new generating capacities for self-consumption from solar/photovoltaic panels in the cadastral parcel No. 01882-0, CA Obiliq, with an installed capacity of 16.32 kW that will be placed over the building, in Municipality of Obiliq, has evaluated them, and has considered that all relevant evidence for the issuance of the decision for construction of self-consumption generating capacities have been fulfilled, and based on the legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause of this Decision.
- V. The Decision is issued and published in the official languages of the Republic of Kosovo.
- VI. The Decision shall enter into force on the date of approval by the Board, and will be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days following the receipt of this Decision or its publication on ERO's website, whichever occurs last.
