- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no. 58-6,59-4 CA Pejë, with an installed capacity of 30 kW, in Municipality of Peja, received on 17.05.2022, from the legal person applicant "MOBILE DEKOR" LLC, having its address at: St. Tahir Shala, no.11, Municipality of Peja, Republic of Kosovo,

in the session held on 24 June 2022, issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request of the applicant "MOBILE DEKOR" LLC, for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no. 58-6,59-4 CA Pejë, with an installed capacity of 30 kW, in Municipality of Peja.
- **II.** The applicant "MOBILE DEKOR" LLC, with electric meter registration number DPE-9020827, **is OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the Electro-Energetic Consent, issued by KEDS JSC.





IV. The applicant "MOBILE DEKOR" LLC shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.

Reasoning

- ERO, on 17.05.2022, received from the applicant "MOBILE DEKOR" LLC the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no. 58-6,59-4 CA Pejë, with an installed capacity of 30 kW, in the Municipality of Peja.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Electro-Energetic Consent no. 11703 dated on 10.11.2021, issued by KEDS JSC., and the Consent No. 08-350/26945, dated on 15.03.2022, issued from the Directorate for Urbanization and Environmental Protection of the Municipality of Peja.
- ERO Board, following the analysis of the request of the applicant "MOBILE DEKOR" LLC, and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no. 58-6,59-4 CA Pejë, with an installed capacity of 30 kW, in Municipality of Peja, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The Decision is issued and published in official languages of the Republic of Kosovo
- VI. This Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
